



SUSTAINABILITY POLICY

1. OUR MOTIVATION

At Quadrante, we work daily to develop sustainable environmental, social, and economic standards, aiming at achieving balance in the systems we engage in, aware of our role and responsibility towards society and the environment. We aim to design and create value through an even more responsible approach, establishing as our purpose: ***'To partner with our clients to Create and Build Sustainable, Responsible and Long-Lasting Infrastructures'***.

We intend to do so through a sustainable business practice that creates environmental, social, and economic value for our clients, all stakeholders, and interested parties, both now and in the future. Our Sustainability Policy serves as the instrument through which all companies within the Group commit to act with determination, integrity, transparency and responsibility as enablers of the sustainable development process.

2. OUR COMMITMENT

Because we are ***'Committed to Sustainability'***, we understand that we can only achieve it when we establish a total balance, meaning an acceptable and lasting harmony between the socio-economic demands of our company, the goals of our projects, the valid expectations of all those who share our success (stakeholders), and the planet's resource regeneration capacity (what we aim to protect and enhance). With this in mind, and because we want to confidently move towards balanced solutions, promoting the best sustainable development practices towards a carbon-neutral future, we embrace our Sustainability Commitment for 2025, which stands on the following pillars:

- **PILLAR 1 - FOCUS ON THE UN's SDGs:** we will annually increase the percentage of our revenue associated with the United Nations Sustainable Development Goals (SDGs) until we reach 80% by 2025;
- **PILLAR 2 – KNOW AND ACT ON OUR CARBON FOOTPRINT:** we will achieve Carbon Neutrality starting from 2022 (in scopes 1 and 2) and consolidate our best practices (in scope 3);
- **PILLAR 3 - DESIGN MORE SUSTAINABLY:** we will develop and apply project support tools throughout the project's life cycle to enhance sustainability performance;
- **PILLAR 4 - MONITOR AND COMMUNICATE OUR PERFORMANCE:** we will monitor and transparently and responsibly disclose the progress of our performance through the publication of our Sustainability Report.
